PAYMENT OPTIONS

1. **Tuition Payment in Full** There is a \$25.00 discount if tuition is paid in full. An invoice will be sent for August 2010 payment.
2. **Tuition Payments by the Month** Facts Tuition Management Co. handles monthly tuition payments. It involves a bank to bank withdrawal. It also necessitates the completion of a contract in April. Payments are made over 10 or 11 months and usually begin in July. There is a \$38.00 transaction fee by Facts Tuition Management.
